

"What's your stance on hazing?"

Student Video Contest – Official Rules

1. DESCRIPTION OF THE CONTEST: The "What's your stance on hazing?" Video Contest sponsored by National Hazing Prevention Week is designed to give Entrants the opportunity to submit videos of their own creation. The Prizes will be awarded to the Entrants who submit the best entries as determined by the judges in their sole discretion in accordance with these Official Rules.

2. ELIGIBILITY: This Contest is open only to active full-time students currently enrolled at UT Arlington.

3. HOW TO ENTER: No purchase necessary. This Contest begins at 8:00 am CST on September 5, 2011, and ends at midnight CST on September 18, 2011. To enter, go to (<http://www.facebook.com/#!/pages/UTA-Mavericks-Against-Hazing/252506718116025>) and follow the onscreen submission process which will require your full name, valid UTA email address, daytime telephone number, name of organization you are representing, and a list of all participants in the video along with each person's major and level in school.

Limit two (2) submissions per organization during the Contest Period. Only one Submission per Entrant can win.

By entering the Contest, Entrant agrees, acknowledges and understands that all submissions may be posted on the Site for viewing by the general public and grants UTA in perpetuity a nonexclusive license to publish, display, reproduce or otherwise use the Submission for the Sponsor and its designees in its sole discretion whatsoever and without further notice or compensation. UTA does not guarantee the posting of any submission and reserves the right not to post a submission for any or no reason.

4. SUBMISSION REQUIREMENTS: Each Submission must also comply with the following:

- Each Submission must be no more than 4 minutes (submissions that exceed 4 minutes will not be considered).
- The primary entrant of an organization will be notified for winning organization(s)
- Only one prize will be given for per winner if there is more than one winner.
- The Submission must be your own original work, created solely by your organization; must not have been previously published, released or distributed in any form; must not have won any award; and must not infringe the copyright, trademark, privacy, publicity, or other personal or proprietary rights of any person or entity.
- Submissions that are lewd, obscene, sexually explicit, pornographic, disparaging, defamatory, libelous, or Submissions that otherwise contain inappropriate content or objectionable material may not be submitted and may be removed at any time in Sponsor's sole and unfettered discretion.

5. FINALISTS SELECTION: NHPW Committee/judges will select three (3) finalists on September 19, 2011, based on the following: (A) viewer likes; (B) originality (C) appropriateness to theme, and (D) quality. All criteria will be judged equally. Odds of winning depend on total number and caliber of eligible entries received during the Contest Period. In the event of a tie, the NHPW committee/judges will break the tie. Winners will receive the Prize Notice via email no later than September 28, 2011. The email will be sent to the email address provided by Entrant in the Submission process. Entrant will have ten (10) calendar days from the date stated on the prize notice to respond with acceptance of the Prize and the completed Affidavit of Eligibility, Waiver and Release, and, except where prohibited, Publicity Release. If the Entrant fails to respond within ten (10) calendar days the prize will be forfeited, the Submission disqualified, and another Submission selected.

6. PRIZES AND APPROXIMATE RETAIL VALUE: The Contest is designed to give Entrants the opportunity to submit videos that respond to the question "what's your stance on hazing?" The Prizes will be awarded to the Entrants who submit the best entries as determined by the judges in their sole discretion in accordance with these Official Rules.
